As Togg, we highly value the processing and protection of your personal data. This Privacy Notice has been prepared in accordance with Article 10 of the Personal Data Protection Law No. 6698 ("KVKK") and the Communiqué on the Principles and Procedures to be Followed in the Fulfillment of the Obligation to Inform, in order to inform you regarding the personal data processed within the scope of your Startup application process.

Startup Application Process

Your personal data regarding **identity information** (name, surname), and **contact information** (e-mail address) will be collected via electronic forms during Trumore registration; and information about your Startup, field of activity, and products will be collected via electronic forms on Startup screens. Your personal data will be processed limitedly for the purposes of conducting Startup application activities, conducting/supervising business activities, and conducting communication activities according to the *"Processing of personal data of the parties of a contract is necessary, provided that it is directly related to the establishment or performance of the contract"* and *"Processing of data is obligatory for the legitimate interests pursued by the data controller, provided that this processing shall not violate the fundamental rights and freedoms of the data subject"* legal basis regulated in Article 5 (2) of the KVKK.

Your personal data may be transferred to authorized public institutions, if necessary, under legal regulations in order to fulfill our legal obligations in accordance with Article 8 of the KVKK. Additionally, your personal data is transferred to our infrastructure provider located abroad for the purposes of storage and archiving activities, in accordance with Article 9 of the KVKK.

Newsletter Request Process

Your personal data regarding **contact information** (email address) will be collected via electronic forms within the scope of your newsletter request. Your personal data will be processed limitedly to carry out communication activities and carry out commitment processes to the company/product/services according to the *"Processing of data is obligatory for the legitimate interests pursued by the data*

controller, provided that this processing shall not violate the fundamental rights and freedoms of the data subject” legal basis regulated in Article 5 (2) of the KVKK.

Your personal data may be transferred to authorized public institutions, if necessary, under legal regulations in order to fulfill our legal obligations in accordance with Article 8 of the KVKK. Additionally, your personal data is transferred to our infrastructure provider located abroad for the purposes of storage and archiving activities, in accordance with Article 9 of the KVKK.

Communication Process

Your personal data regarding **identity information** (name, surname), **contact information** (email address, phone number), and message contents will be collected via electronic forms within the scope of your communication process. Your personal data will be processed limitedly to carrying out communication activities, tracking requests/complaints, and conducting necessary research to provide support services according to the *“Processing of data is obligatory for the legitimate interests pursued by the data controller, provided that this processing shall not violate the fundamental rights and freedoms of the data subject”* legal basis regulated in Article 5 (2) of the KVKK.

Your personal data may be transferred to authorized public institutions, if necessary, under legal regulations in order to fulfill our legal obligations in accordance with Article 8 of the KVKK. Additionally, your personal data is transferred to our infrastructure provider located abroad for the purposes of storage and archiving activities, in accordance with Article 9 of the KVKK.

Your Rights and Application Methods of Your Personal Data

You have the rights to request regulated in Article 11 of the KVKK:

- to learn whether your personal data are processed or not,
- to demand for information as to if your personal data have been processed,
- to learn the purpose of the processing of your personal data and whether these personal data are used in compliance with the purpose,
- to know the third parties to whom your personal data are transferred in country or abroad,
- to request the rectification of the incomplete or inaccurate data, if any,
- to request the erasure or destruction of your data under the conditions referred to in KVKK,
- to request reporting of the operations carried out to third parties to whom your personal data have been transferred,
- to object to the occurrence of a result against yourself by analyzing the data processed solely through automated systems,

- to claim compensation for the damage arising from the unlawful processing of your personal data.

Also, you can decide on other methods to send requests and applications provided from Communiqué On The Principles And Procedures For The Request To Data Controller.

Your request for your rights regulated under Article 11 of the KVKK will be concluded as soon as possible regarding the nature of the request and thirty days at the latest, free of charge. However, if the transaction also requires an additional cost, you may be charged based on the tariff determined by the Personal Data Protection Board.
